RENTAL AGREEMENT

- 1. I accept full responsibility for the care of any rental equipment (the "Equipment") rented during WinSport's 2025 Mountain Bike Season and I agree to pay WinSport for any damage to the Equipment, unless covered by WinSport's Equipment Damage Protection Plan purchased by me, and I agree to pay WinSport for the full retail value of the Equipment if not returned by the end of each rental period or damaged beyond repair. I understand that I will be required to provide my credit card number as security for the Equipment and I hereby authorize WinSport to charge my credit card for any damage or loss. I also agree to return the Equipment in a clean, undamaged condition to avoid any additional charges.
- The Participant is familiar with the proper use of the Equipment including but not limited to all quick release mechanisms, brakes and gear shifters. I am aware that there are technicians available to answer questions the Participant may have as to the proper use of the Equipment.
- 3. I will provide the Participant's accurate height and weight where required. (This information is required in order to properly adjust the Equipment, including bike suspension.) I acknowledge that WinSport will be relying on the information provided by me to provide the Equipment for the duration of WinSport's 2025 Mountain Bike Season. I agree that if the Participant's height or weight changes during WinSport's 2025 Mountain Bike Season, I will inform WinSport prior to receiving the Equipment.
- 4. I agree that the Equipment shall only be used at WinSport's Canada Olympic Park ("COP") and shall not be removed from COP under any circumstances, including without limitation the lands to the east of COP known as the "Eastlands," unless the Equipment is being used away from COP during a WinSport supervised program, lesson, or camp.
- I agree to refer to the Mountain Biker's Responsibility Code, Mountain Bike Checklist, and bike safety signage for further safety information.

MOUNTAIN BIKE EQUIPMENT RENTAL WAIVER

ASSUMPTION OF RISKS

I am aware that injuries are a common and expected part of Mountain Biking. Mountain Biking takes place on steep and rugged terrain and features that are both physically and technically challenging and will expose the Participant to many risks, dangers, and hazards. I am aware that biking at the Premises involve risks, dangers and hazards and that injuries are a common and ordinary occurrence in these sports. These include but are not limited to: mechanical failure of bikes and other equipment; improperly adjusted or maintained bikes and other equipment; falls; loss of balance; high-speed descents; difficulty or inability to control one's speed and direction; rapid or uncontrolled acceleration on hills and inclines; impact or collision with natural and constructed objects, lift towers, other bikers, vehicles, pedestrians, spectators and officials; exposure to infectious disease contracted through viruses, bacteria, parasites, and fungi which may be transmitted through direct or indirect contact; negligence of other persons; and NEGLIGENCE ON THE PART OF THE RELEASES. I UNDERSTAND THAT NEGLIGENCE INCLUDES INCOMPLETE INSTRUCTIONS AND THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT FROM, OR WARN OF, THE RISKS, DANGERS AND HAZARDS USING THE EQUIPMENT OR OF MOUNTAIN BIKING AT THE PREMISES. I am also aware that these risks, dangers, and hazards exist throughout the Premises and that many hazards are unmarked.

I AM AWARE OF, FREELY ACCEPT AND FULLY ASSUME ALL OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE USE OF THE EQUIPMENT, PARTICIPATION IN BIKING AND MY PRESENCE AT THE PREMISES, AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE, OR LOSS RESULTING THEREFROM. MY PARTICIPATION IN I AGREE (Initials) THESE ACTIVITIES IS PURELY VOLUNTARY AND I ELECT TO PARTICIPATE DESPITE THESE RISKS, **DANGERS AND HAZARDS.**

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Releasees allowing use of services, equipment, and facilities at COP (the "Premises") and the rental of the Equipment, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury, including death, that I may suffer, or that my next of kin may suffer, resulting from or arising out of any aspect of my use of the Equipment or my presence on the Premises, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS' LIABILITY ACT, RSA 2000, c O-4. I UNDERSTAND THAT NEGLIGENCE INCLUDES IMPROPER DESIGN, MANUFACTURE, INSTALLATION, SELECTION, ADJUSTMENT, MAINTENANCE, REPAIR OR SERVICE OF THE EQUIPMENT, INCOMPLETE INSTRUCTIONS AND THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM, OR WARN ME OF, THE RISKS, DANGERS AND HAZARDS OF MOUNTAIN BIKING OR USING THE EQUIPMENT OR USING THE PREMISES, OR THE PROVISION, OR THE FAILURE TO PROVIDE, ANY WARNINGS,

DIRECTIONS OR INSTRUCTIONS AS TO SAFETY, INCLUDING MOUNTAIN BIKING SAFETY, OR THE **SAFE USE OF THE EQUIPMENT;**

- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage, loss, or personal injury to any third party resulting from my use of the Equipment, my participation in biking, or my use of or presence on/at the Premises;
- 3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity;
- 4. This Release Agreement and any rights, duties, and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of Alberta and no other jurisdiction;
- 5. Any litigation involving the parties to this Release Agreement shall be brought solely within Alberta and shall be within the exclusive jurisdiction of the Courts of Alberta; and
- 6. If any provision of this Release Agreement is held by a Court to be unenforceable, then such provision will be modified to reflect the Participant and Releasees' intention. All remaining provisions of this Release Agreement shall remain in full force and effect as drafted.

In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of the Equipment or of biking or the Premises other than what is set forth in this Release Agreement.

I CONFIRM THAT I HAVE READ I AGREE TO THIS RELEASE AGREEMENT. I AM AWARE THAT, BY SIGNING THIS RELEASE AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES, INCLUDING THEIR RIGHT TO SUE. I ACKNOWLEDGE THAT I AM SIGNING THIS RELEASE AGREEMENT FREELY AND VOLUNTARILY AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
