TO: CALGARY OLYMPIC DEVELOPMENT ASSOCIATION, operating as WinSport and its directors, officers, employees, instructors, guides, agents, representatives, volunteers, independent contractors, subcontractors, sponsors, insurers, successors, and assigns (hereinafter collectively referred to as the "Releasees").

RENTAL AGREEMENT

- 1. I accept full responsibility for the care of any rental skates, helmets and other equipment (the "Equipment") rented from WinSport and I agree to pay WinSport for any damage to the Equipment and to replace at full retail value any Equipment not returned by the agreed date.
2. I also agree to return the Equipment in a clean, undamaged condition to avoid any additional charges.
3. I am familiar with the proper use of the Equipment. I understand there is arena staff available to answer questions I may have as to the proper use of the Equipment.
4. I agree the Equipment shall only be used at WinSport's arenas located at Canada Olympic Park ("COP") and shall not be removed from COP under any circumstances, unless the Equipment is being used away from COP during a WinSport supervised program, lesson, or camp.

ASSUMPTION OF RISKS

I am aware that ice skating, ice hockey, ringette, and other on-ice activities (collectively "On-Ice Activities") involve many risks, dangers and hazards and that injuries are a common and ordinary occurrence in these activities. Such risks, dangers and hazards include but are not limited to: unwanted collision or impact with projectile objects or equipment; collision or impact with equipment, other persons, or natural or man-made obstacles; cuts or abrasions from equipment; improper use or failure of equipment; power, mechanical or structural failure of facilities, terrain or equipment; falling off equipment or from heights; failure to properly adjust or fasten equipment; exposure to cold conditions; sudden stops or changes in direction; failure to act safely or within one's own ability or to stay within designated areas; slips, trips, falls, or loss of balance; difficulty or inability to control one's speed or direction; changes or variations in terrain or surface, including but not limited to cracks, ruts, etc.; negligence of other persons; a medical condition, whether known or unknown; and NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES INCOMPLETE INSTRUCTIONS AND THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT FROM, OR WARN OF, THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE OR OF USING THE PREMISES. I am also aware that these risks, dangers, and hazards exist throughout WinSport's facilities and that many hazards are unmarked.

HELMETS I understand that a helmet designed for recreational activities on ice may reduce the risk of some types of head injuries. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I AM AWARE OF, FREELY ACCEPT AND FULLY ASSUME ALL OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE USE OF THE EQUIPMENT, PARTICIPATION IN ON-ICE ACTIVITIES AND MY PRESENCE AT THE PREMISES, AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM. MY PARTICIPATION IN THESE ACTIVITIES IS PURELY VOLUNTARY AND I ELECT TO PARTICIPATE DESPITE THESE RISKS, DANGERS AND HAZARDS

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the rental of the Equipment, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against **THE RELEASEES**, and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, expense or injury, including death, that I may suffer, or that my next of kin may suffer, resulting from or arising out of any aspect of my use of the Equipment, participation in the On-Ice Activities or my presence on the Premises associated with the On-Ice Activities, **DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS' LIABILITY ACT, RSA 2000, c O-4. I UNDERSTAND THAT NEGLIGENCE INCLUDES IMPROPER DESIGN, MANUFACTURE, INSTALLATION, SELECTION, ADJUSTMENT, MAINTENANCE, REPAIR OR SERVICE OF THE EQUIPMENT, INCOMPLETE INSTRUCTIONS AND THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM, OR WARN ME OF, THE RISKS, DANGERS AND HAZARDS OF ANY ON-ICE ACTIVITIES OR USING THE EQUIPMENT OR USING THE WINSPORT FACILITIES, OR THE PROVISION, OR THE FAILURE TO PROVIDE, ANY WARNINGS, DIRECTIONS OR INSTRUCTIONS AS TO SAFETY, INCLUDING ON-ICE SAFETY, OR THE SAFE USE OF THE EQUIPMENT;**

- 2. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any property damage, loss, or personal injury to any third party resulting from my use of the Equipment, my participation in On-Ice Activities, or my use of or presence on/at the Facilities;
- 3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity;
- 4. This Release Agreement and any rights, duties, and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of Alberta and no other jurisdiction;
- 5. Any litigation involving the parties to this Release Agreement shall be brought solely within Alberta and shall be within the exclusive jurisdiction of the Courts of Alberta; and
- 6. If any provision of this Release Agreement is held by a Court to be unenforceable, then such provision will be modified to reflect the Participant and Releasees' intention. All remaining provisions of this Release Agreement shall remain in full force and effect as drafted.

In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of the Equipment or of On-Ice Activities or the Premises other than what is set forth in this Release Agreement.

I CONFIRM THAT I HAVE READ AND I AGREE TO THIS RELEASE AGREEMENT. I AM AWARE THAT, BY SIGNING THIS RELEASE AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES, INCLUDING THEIR RIGHT TO SUE. I ACKNOWLEDGE THAT I AM SIGNING THIS RELEASE AGREEMENT FREELY AND VOLUNTARILY AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
