DEFINITION


In this Release Agreement, the term "Activities" shall include all activities, events and services provided, arranged, organized, conducted, sponsored, hosted, or authorized by the Releasees relating to its Survival Skills & Youth Leadership Programs and Camps, including without limitation: building and maintaining fires using friction, flint, lighters, and matches; fire safety; knife skills; knife whittling, carving; foraging and identifying fauna and flora; first aid education; front country packing; shelter finding and building using ropes, tarps, and the natural environment; archery; hiking; group team building; running; jumping; group sports; field games; knot tying and lashing; on and off-site bear and animal awareness; setting up a campsite; daily hikes both on and off-site (including hikes led by third-parties); set-up, ignition, and use of camping or backcountry stove; cooking using a campfire or backcountry stove; compass and map use; navigating without a compass; tool usage including without limitation, hammers and nails, sand paper, hand saws, shovels; and all other such activities, events and services in any way connected with or related to the Releasees, or travel to/from and presence at any activity areas or Facilities (defined below). and off-site hiking locations.

ASSUMPTION OF RISKS

I am aware that participation in the Activities involves many risks, dangers and hazards including, but not limited to: hiking on and off-site (including in wilderness areas outside city limits); collision or impact with equipment, other persons, or natural or man-made obstacles; physical contact, such as body contact or physical aggression from other participants; unwanted contact with projectile objects or equipment; cuts, burns or abrasions from equipment such as knives, ropes, camping stoves and fires; being struck by or pierced by equipment such as knives, arrows and other archery equipment; improper use or failure of equipment; falling off or being ejected from equipment or from heights; failure to properly adjust or fasten equipment; inadequate equipment; power, mechanical or structural failure of facilities, terrain, or equipment; inadequate course conditions; changing weather conditions or exposure to extreme weather conditions; slips, trips, falls or loss of balance; the failure to act safely or within one's own ability or to stay within designated areas; difficulty or inability to control one's speed or direction; sudden stops or changes in direction; failure to slow or stop in designated areas;

becoming lost or separated from the guides or instructors or other participants; variable or difficult conditions; exposed rock, earth, ice, trees, tree stumps, forest deadfall, and other natural objects; fire; hot cooking equipment; changes or variations in terrain, such as holes, depressions, loose gravel, rocks, mud, creeks, bumps, berms, steep or slippery sections, cracks, ruts, etc.; negligence of other persons; drowning (when near, on, or in water); encounters with domestic or wild animals including large animals such as bear, elk or moose; insect bites or stings; a medical condition, whether known or unknown; allergic reactions; choking; disorientation; fatigue; overexertion; mechanical failure of vehicles, motor vehicle accidents or collisions, poor road conditions; negligent first aid; infectious disease contracted through viruses, bacteria, parasites, and fungi which may be transmitted through direct or indirect contact; and **NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES INCOMPLETE INSTRUCTIONS AND THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT FROM, OR WARN OF, THE RISKS, DANGERS, AND HAZARDS OF THE ACTIVITIES OR THE FACILITIES.** I am also aware that these risks, dangers, and hazards exist throughout the Facilities and surrounding areas and that many hazards are unmarked.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

In consideration of the Releasees allowing participation in the Activities and permitting the use of their equipment, trails, hill, restaurants, day lodge, parking, access roads and other facilities, which facilities shall include any and all areas and premises where the Activities are provided by the Releasees, whether owned by the Releasees or not (collectively, the "Facilities"), I hereby agree as follows:

**1. TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against **THE RELEASEES**, and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my participation in the Survival Skills & Youth Leadership Programs and Activities or my use of or presence on/at the Facilities, **DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS' LIABILITY ACT, RSA 2000, c O-4, ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES INCOMPLETE INSTRUCTIONS AND THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM, OR WARN ME OF, THE RISKS, DANGERS, AND HAZARDS OF THE ACTIVITIES OR USING THE FACILITIES;**



- 2. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability for any property damage, loss, or personal injury to any third party resulting from my participation in the Activities, or my use of or presence on/at the Facilities;
- 3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity;
- 4. This Release Agreement and any rights, duties, and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of Alberta and no other jurisdiction;
- 5. Any litigation involving the parties to this Release Agreement shall be brought solely within Alberta and shall be within the exclusive jurisdiction of the Courts of Alberta; and
- 6. If any provision of this Release Agreement is held by a Court to be unenforceable, then such provision will be modified to reflect the Participant and Releasees' intention. All remaining provisions of this Release Agreement shall remain in full force and effect as drafted.

In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of the Activities or the Facilities other than what is set forth in this Release Agreement.

**I CONFIRM THAT I HAVE READ AND I AGREE TO THIS RELEASE AGREEMENT. I AM AWARE THAT, BY SIGNING THIS RELEASE AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES, INCLUDING THEIR RIGHT TO SUE. I ACKNOWLEDGE THAT I AM SIGNING THIS RELEASE AGREEMENT FREELY AND VOLUNTARILY AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.**
